## **Visa Policy:**

We provide visa for your esteemed guests at the rate of BHD. 25.000 net for 14 days visa single entry and the following are required:

(Payments for Visa and room Rent should be in advance and please note BHD 10.000 will not be refundable in case of any Rejection.)

- Clear passport copy.
- Copy of the GCC residential visa.
- Vaccination certificate
- The credit card authorization form duly filed to guarantee the visa fees and no-show charges.
- Kindly Mention the guest's profession as mandatory, passport number written in company letter head with stamps and signature.

Please note that as per Department of Immigration, we require 7 to 14 working days to process the visa.

## **Meal rates supplement:**

Breakfast Buffet – BD 5.000 subject to 10% service charge +5% govt. tax & 10 % VAT

## **Meals Child policy:**

Less than 1 to 5 years old = no charges applied

6 to 11 years old = 50% charge

12 years old and above = 100% charge as adult price

## **Children Policy:**

- Children under 12 years of age can stay free in their parent's room (in existing bedding). Children of 12 years of age and above will be charged the full rate.
- Children between 2-6 years of age are entitled to free breakfast. Children between 6-12 years of age are entitled to a 50% discount on meal prices.
- Extra Person and Bed Surcharge were permitted under the occupancy allowance is subject to any waiver of charges by the hotel described herein:
